## The impact of the pandemic:

The COVID-19 pandemic has had a significant impact on the lives of everyone. For the children and young people of Torfaen, the disruption to learning as a consequence of the initial lockdown, the move to blended learning and the continual to and fro of self-isolation and subsequent lockdowns have all taken their toll on their mental health and progress in learning. For older learners taking public examinations, it has meant significant additional anxiety as examinations were cancelled and progression routes onto further and higher education, and employment called into doubt.

As a Local Authority, Torfaen fully understands all these additional issues. We have worked in close collaboration with Council Members, schools and learners across the borough to put in place measures in an attempt to address the gaps in learners' knowledge and understanding and enhance our support to address mental health issues for our children and young learners.

Consequently, in addition to our core vision for education, Torfaen have added two further priorities in the short and medium term to specifically address these issues and mitigate against the negative impact on the wellbeing and future life chances of all children and young people in the borough.

*To work tirelessly in collaboration with schools, external providers and Welsh Government to address the identified skills and knowledge gaps of learners through the provision of recovery programmes and additional learning resources.*

*As a Council service embrace and embed beneficial new ways of working arising from the pandemic to enhance the quality and impact of the service's support to schools and provision within schools.*



## Strategic context:

**Torfaen County Borough Council Corporate Plan 2016-21** is the over-arching vision of the Council, which lays out its clear priorities over a five-year period. The third priority within the plan (CP3) is **“raising educational attainment”**. 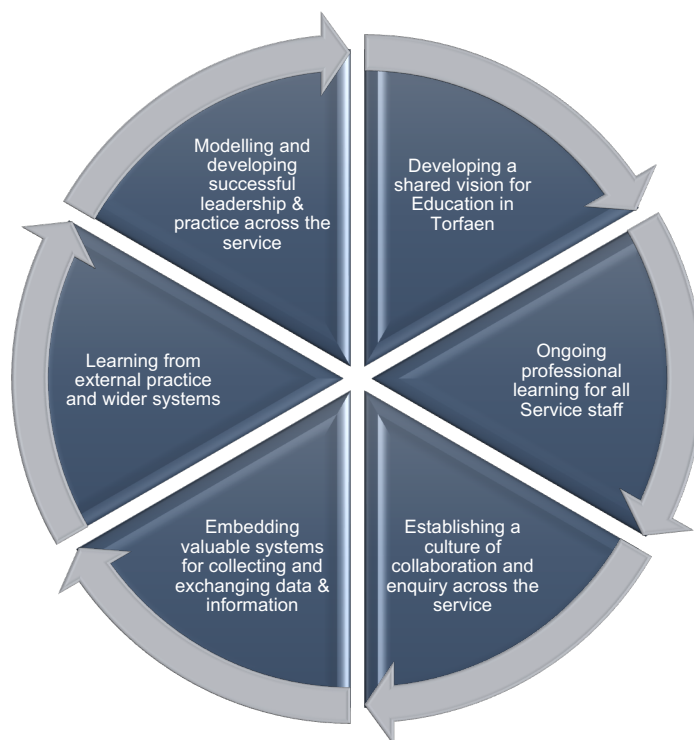

Our work in collaboration with Bangor University has seen the Education Service implement beneficial changes aligned to the OECD's principles around successful learning organisations. It also mirrors the best practice in many of Torfaen's highly effective schools.



The strategic intent of this development is to:

Enhance the Service's capacity to support its schools to deliver the key changes to education provision in Torfaen as outlined in the Donaldson Report and the Curriculum Reform Wales document.

Develop systems and practice across the Service that enhance the productivity and effectiveness of its staff to successfully support schools in securing the necessary progress against the conditions found in good schools.

Establish a common understanding and practice aligned to our stakeholders that accelerates the progress made by Torfaen schools, particularly in the secondary sector.
